Alcohol and Drug Programs:

The Organization is one of the few nonprofit substance-abuse agencies in Northern Nevada that incorporates evidence-based practices into service delivery. The Organization provides outpatient therapy for adults and adolescents with substance abuse and mental health disorders. Services include individual and family counseling, Alcoholic Beverage Awareness Training (ABAT), presentations and workshops, community prevention programs, felony DUI and diversion court programs for adults, and comprehensive substance abuse and mental health evaluations.

4b (Code:) (Expenses \$ 434,000. including grants of \$ 0.) (Revenue \$ 0.)

Adults & Adolescents with Co-occurring Disorders:

Co-occurring disorders develop as a result of a dual diagnosis of substance abuse and mental health disorders. According to research studies, simultaneous treatment of both issues is the most effective on clients who have been diagnosed. The Organization contracts with a child psychiatrist and a psychologist to ensure the most appropriate and successful interventions. Individual, group and family therapy is used to help the adolescent learn the skills and tools to successfully manage their lives.

4c (Code:) (Expenses \$ 294,809. including grants of \$ 0.) (Revenue \$ 317,501.)

Washoe County Juvenile Services Programs:

The Organization has three contracts with Washoe County and is the sole provider for the Washoe County Juvenile Drug Court, offering Multi-Dimensional Family Therapy (MDFT) and Cognitive Behavioral Therapy (CBT) to adolescents sentenced to the drug court. MDFT is a time and resource intensive therapeutic intervention which incorporates individual and family therapy while also looking holistically at the client's environment (e.g., school, probation, and physical health.) The Organization also contracts with Washoe County to provide drug and alcohol counseling to any referred adolescent involved with the juvenile justice system and has a separate contract with the Department of Social Services for adults.
